JUDGMENT

T Kulasekaram J:

This is an application by the General **Accident** Fire & Life Assurance Corp (hereinafter referred to as the respondents) to set aside a joint final award made by two arbitrators in connection with a claim arising out of a motor insurance policy issued by the respondents in respect of motor car SR 7408.

It will be convenient here to set out the circumstances giving rise to these arbitration proceedings. As the learned Chief Justice has already done this in his judgment in the Court of Appeal when considering an earlier interim award made by these two arbitrators in these same arbitration proceedings I could at this stage do no better than to quote here what he then said there:

The claim which was referred to the arbitrators arose out of a collision between two motor vehicles, a private motor car No SR 7408 and a motor lorry, which occurred on 8 August 1963. Motor car No SR 7408 was owned by one Shaik Baobid to whom the respondents had issued a policy of insurance pursuant to which the car was insured from 9 July 1958 to 8 July 1959. This policy was renewed from time to time and was in force on 8 August 1963.

As a result of the said collision the driver of the car, Elahideen Doray bin Booso and two passengers were killed and four other passengers were injured. Elahideen Doray, the driver of the car at the time of the **Accident**, was driving it with the authority of the owner and policyholder, but not as the policyholder's servant or agent.
